We are going to show and prove right here with Stella Reddy's own words and documents that she was the property manager at 859 Kennedy Road and worked for the owners [REDACTED] and his son [REDACTED].

What is the significance of this? Why is this important?

Because Stella Reddy is a compulsive liar and is willing to throw anyone, including her past and current employers under the bus in what appears to be her trying to save her own ass and reputation.

Stella Reddy is willing to deliberately lie, even when confronted with indisputable facts and evidence that shows her to be the liar that she is.

Stella Reddy has contentiously lied and upheld these deliberate lies in her attempt to try distance, justify and deflect from her racist behaviour against interracial married couples / tenants at 859 Kennedy Road.

Let us note that there is absolutely no reason for Stella Reddy to try and lie about her job title. It makes no difference what her job title was at 859 Kennedy Road.

The disputable facts are that she worked for [REDACTED] and his son [REDACTED] and their company Alto Properties Inc. She and her husband [REDACTED] maintain their apartment building 859 Kennedy Road.

But this issue of her self-proclaimed job title of being superintendent verses the property manager is very important to Stella Reddy.

So let us start with all of Stella Reddy's denials and numerous times she deliberately refuses to admit that her job title at 859 Kennedy road was that of property manager and not superintendent.

Document # 10 – *Stella Reddy stated in her own document labelled " August 15.docx " sent to the Human Rights Tribunal of Ontario on August 24, 2018 on page # 01 " My husband, and I have worked in PROPERTY MANAGEMENT looking after apartment buildings since Sept 2000, except for the year we went back to Newfoundland from Aug 2009- Dec 2010. We moved here from Newfoundland in the fall of 1999 "*

Stella Reddy appears to indicate in her very own words that she and her husband [REDACTED] [REDACTED] have had a long career in " Property Management " and that includes working for Alto Properties Inc. owner [REDACTED] and Alto Properties Inc. owner [REDACTED] at the time of writing it.

Stella Reddy stated in her own document labelled " August 15.docx " sent to the Human Rights Tribunal of Ontario on August 24, 2018 on page # 10 " and most times I actually quote the regulations I copy and paste directly from the written rules, as I prefer the rules and regulations of property management to speak for me, rather than use my own personal words. "

Could this be a Freudian slip on the behalf of Stella Reddy?

Is this her sub-conscious talking the actual truth about her actual position with Alto Properties Inc.?

A month and a half later on October 11, 2017 while still working at 859 Kennedy Road. Stella Reddy's A.K.A. Lorrie Reddy's LinkedIn account stated under the caption of Headline that she classified herself as a " Property Administrator at Property Manager Management "

Stella Reddy also typed under the caption Current Position " Property Management "

We have placed a picture of Lorrie Reddy's Instagram account here so as to prove and to avoid any confusion if Lorrie Reddy is really Stella Reddy.

You see Stella Reddy, A.K.A. Stella Jones, A.K.A. Lorrie Reddy has multiple social media accounts under different names and even duplicates accounts within the same social media itself. This is the only accounts that were were able to verify, but we suspect there is more.

It is clear that for some reason Stella Reddy believes, that if she believes, she has down grading her job title. It will negate her responsibilities and her accountability for her past racist actions and behavior .

With this downgrade in job titles. Stella Reddy and [REDACTED] are trying to place the entire blame on the owners [REDACTED] and his son [REDACTED] as they themselves were limited in their role around decisions being made at 859 Kennedy Road. But in the end all parties involved are reasonable for the behavior of Stella Reddy.

The interracial married couple / tenants brought the racist behavior of Stella Reddy to the owners [REDACTED] and his son [REDACTED] attention immediately in a letter. The owners of Alto Properties Inc. [REDACTED] and [REDACTED] decided not to address the interracial married couples (tenants) concerns, because cheap labor was more important that issues of racism by their staff!

Stella Reddy stated in her own document labelled " August 15.docx " sent to the Human Rights Tribunal of Ontario on August 24, 2018 on page # 02 " Our duties were of a building superintendent to look after the renting, administration, and common area cleaning and maintenance for the tenants in a 34 unit building. It is also our job to enforce the rules of various agencies such as Fire Safety, Property Standards, Residential Tenancies Act, ESA, Health and Safety as well as others. We also work with and take direction from the property owners on rental rates, office and cleaning procedures "

Now if all this was not enough proof yet, that Stella Reddy was in fact the property manager at 859 Kennedy Road. Stella Reddy next set of words and documents should make any doubter believe.

*So back in August of 2016, two years before Stella Reddy decided to try and distance herself from being the actual property manager at 859 Kennedy Road to a superintendent. Stella Reddy openly and proudly admitted in a email that she was the **REGISTERED PROPERTY MANAGEMENT**.*

There seems to be something very astonishing about this information. It appears that Stella Reddy also uses the same address Suite #100-859 Kennedy Rd, Scarborough ON M1K 2E3, as the " registered property management "

It appears that Stella Reddy also uses the same phone number 416-752-3030, as the "registered property management"

It appears that Stella Reddy also uses the same email address 859kennedy@gmail.com, as the "registered property management"

In fact, this very email sent by Stella Reddy to the interracial married couple/tenants was sent from this very same email address used by the "registered property management".

In fact, this same "registered property management" information is also on all the notice of entry and letters created by Stella Reddy.

Again this same "registered property management" information is on every single letter that Stella Reddy has ever written to the tenants. Including the letter she sent out on September 21, 2017 where she stated at the end of the letter " Best Regards Property Management ".

In the letter by the alleged Alto Properties Inc. Property Manager Stella Reddy, she encouraged tenants to reach out as " The staff is always available by telephone at the number above " and " If you have any questions or issues please feel free to contact us " at the registered property management contact information in the top right-hand corner that ONLY SHE USES!

Remember growing up when your parents said..

If it walks like a duck, looks like a duck, sounds like a duck, and acts like a duck... It's a duck!

So Stella Reddy's own email is a contradiction of her own words from her blog where she posted recently on June 04, 2020.

" The owners here called me the building manager, which is why manager was on the board, as

it was shorter that either building manager and superintendent. Logical don't you think? I never used it, ever, in my whole career in the industry as it takes certification to be able to use that title "

It appears that Stella Reddy thinks that if you are property management, you are not necessarily the property manager. How do I even address this foolishness? Her words speak for themselves.

So it has been well established that was Stella Reddy was the property manger at 859 Kennedy Road. But let us put that off to the side for a brief minute and look at the real issue at hand.

The real reason for this web detailed break down of Stella Reddy's deliberate lies is to expose her for what she is. A pathological liar, con-artist, ungrateful employee and a deliberate racist who will lie under any circumstance to try and save her own reputation when called out for her anti-black racist behavior and actions.

Stella Reddy when confronted with the truth will always lie, play the victim and as you have seen here, try and play the sympathy card in hopes of using the proverbial hand grenade as a way to distract from her anti-black racist actions and behavior to gain pity. It really is pitiful!

That is what racist do, among many other things. Racist have a very common play book that they reference too when they are caught. And Stella Reddy is no different.

Stella Reddy has been using the systematic racism of the judicial system and the Social Justice Tribunals of Ontario to do her bidding for her!

And an elder indigenous man reply's in a caption – I'VE NEVER BEEN TO EUROPE.

Stella Reddy commented on this individuals meme on January 12, 2019 by visiting the individuals account and leaving a comment and attaching the individuals user name to her comment about their meme to ensure that the individual would be notified of her comment to their post @therealdonaldtrump

Stella Reddy commented on the individuals meme that they were an " asshole " for the posting the meme in response to the tweet by Donald Trump @therealdonaldtrump.

It is clear that Stella Reddy @sredd46 was very upset at this individual who was calling out Donald Trump and his tweet.

1 – Stella Reddy could have retweeted Donald Trumps original post and attached an " asshole " comment to her retweet if the " asshole " comment was really meant and directed at Donald Trump.

2 – Stella Reddy could have also just replied or commented directly to the original tweet by Trump on his account @therealdonaldtrump, if the " asshole " comment was really meant and directed at Donald Trump.

3 – Stella Reddy could have also attached /included Donald Trumps username @therealdonaldtrump in her comment in the individuals account, on the meme. Which

would then notify Donald Trump about her " asshole " comment if the " asshole " comment was really meant and directed at Donald Trump.

4 – Or Stella Reddy could have just said in plain text in the individual's post " Donald Trump is an asshole " instead of just " asshole " if the " asshole " comment was really meant and directed at Donald Trump.

But Stella Reddy did none of the above, instead Stella Reddy directly commented in the individual's account, on the meme and wrote " asshole ".

It is clear that it was not meant or directed at Donald Trump. Instead it was direct at the individual who posted the meme as she attached his username to her comment of " asshole. " So any person who searches this individual's username will see the meme and the comment left by Stella Reddy.

It is clear that Stella Reddy's comment of " asshole " was directed only at the individual of the meme. As she makes no attempts to attach the " asshole " comment to Donald Trump and is username @therealdonaldtrump in any way.

It appears that Stella Reddy is a strong defender of the racist President Donald Trump as she clearly has come to his defense when the individual simply heckled the Donald Trump on what appears to be his immigration policies.

Is it that Stella Reddy has the same views as Donald Trump and wants all indigenous individuals or maybe all non-whites to get out of her country?

What we do know is that Stella Reddy is not happy with this individual's meme that mocks her apparently favorite celebrity and President Donald Trump!

Stella Reddy even doubles down on this prejudice slur Newfie during the public hearing so as to imply that it has some form of relevance and proof to her argument that she is not a racist.

Apparently Stella Reddy does not understand or does not care that the term Newfie is defined as a prejudice slur that was used in Newfie jokes that depicts Newfoundlanders as stupid and foolish. Newfoundlanders consider Newfie as a slur, as it was used by American and Canadian military forces stationed on the island.

Now let us remember that Stella Reddy tried to act as if she was so naive as to not know what the word Mulatto meant while using it in the correct context..

And now she is using a prejudice slurs Newfie in a public forum and in the proper context, again?

And what did Stella Reddy do when presented with this letter? Nothing, not a damn thing!

What did the owners Luigi Lisico and his son [REDACTED] do when presented with this letter? The same thing as they did the entire time until the interracial married couple / tenants moved out. Nothing, not a damn thing!

The owners Luigi Lisico and his son [REDACTED] sat on their hands and encouraged and participated in helping Stella Reddy and her husband [REDACTED] to continue with their racist and anti-black behavior.

Why?

*Because according to the all of them the interracial married couple / tenants were just racist instigators for calling out Stella Reddy in their **seven pages long, with full of racist slurs** letter.*

*Stella Reddy is trying to convince the racist Caucasian SJTO member [REDACTED] (**like she did with here bosses**) that because she is the obvious Caucasian here, and that she was born and raised in Canada (**Newfoundland**) and was educated and trained and has worked her entire life in Canada.*

Stella Reddy is sending the subtle message to the racist SJTO member [REDACTED] that she is defiantly the better person to bet here in this situation.

*Stella Reddy believes she is more educated and smarter the female of the interracial married couple / tenants. This is why Stella Reddy reminded the female of the interracial married couple / tenants back in August 2016 that she has **been working in property management for 16 years, here in Canada!***

Now let us go back and look at Stella Reddy's claims that because she is from Newfoundland that she cannot be a racist.

What is amazing is that Newfoundland is extremely racist, especially because it has such a small population.

*Reviewing the links on the page, one will see that racism is alive and well in Newfoundland and despite Stella Reddy trying to indirectly claim that there is no racism in Newfoundland. Newfoundland in fact is a hot-spot for racism, as the facts, articles (**links**) show differently.*

Newfoundland has even segregated the only black child in a town. Forcing him to use a separate washroom, while under constant supervision at school. Because they were unwilling to correct the Caucasian kids for bullying and making racist and offensive slurs against him

And still Stella Reddy proudly claims that she is the prejudice and offensive slur **Newfie** from Newfoundland without fear or respect for others!

– I have very beautiful great grand, great nephews and nieces who are half Black –

And there we go, Stella Reddy just said it!

Just like Mark Meadows and his – **My nieces and nephews... are people of color.**

We now have the Stella Reddy and her – **I have very beautiful great grand, great nephews and nieces who are half Black.**

Again this routine is the greatest and most used racist excuse used by all offenders to try to make it look like they are not racist.

First, Mark Meadows and now Stella Reddy think that by having non-white **nephews and nieces** in their own families. That this negates any racist things they have ever said and/or did in the past.

Stella Reddy uses this racist routine to try and pardon her own racist and anti-black behavior. Stella Reddy needs to understand this is not a legitimate argument.

Again even the racist President Donald Trump has Black friends!

Stella Reddy was quick to objectify her **nephews and nieces** a verbal props in her attempts to justify why she is not a racist. Again no matter how you phrase it.

– My nieces and nephews... are people of color.

– Nephews and nieces who are half Black.

It is still racist to try and use a individuals skin complexion as a token, tool and prop to try and convince people that you like or love them!

*Let us note that Stella Reddy gave her own **nephews and nieces** the respect of being identified as the more acceptable term of being **half Black** when using them as verbal props in a public forum.*

Stella Reddy was not so considerate when referring to the interracial married couples / tenants bio-racial children with the racist term Mulatto, TWICE!

Stella Reddy labelled the interracial married couple / tenants present in person bi-racial children with the derogatory term Mulatto back in June 2016 and again while in front of the racist SJTO member [REDACTED] in September 2017.

The Hero / Good Samaritan Routine

*The fact that Stella Reddy would make this implied claim that because she has bi-racial **nephews and nieces** in her family and therefore she can't be racist is ridiculous.*

*Stella Reddy wants people to believes that she is a **Hero / Good Samaritan Routine** because she has allowed these **nephews and nieces** that are half-Black into her Caucasian family. Is Stella Reddy really trying to push this narrative?*

*Stella Reddy believes and has convince herself that by having a token **nephews and nieces who are half Black** in her family that she is not racist.*

*It appears that Stella Reddy thinks she is the Queen of her own Monarchy. And that these **nephews and nieces who are half Black** should be thankful and appreciative to her for their acceptance into her Caucasian family.*

*What Mark Meadows and Stella Reddy do not realize is that they **HAVE ABSOLUTELY NO CONTROL** over who their immediate or extended family members decided to have relationships with or have children with.*

*That they have **HAVE ABSOLUTELY NO CONTROL** over if a non-white is gonna become part of their Caucasian family or not!*

When Stella Reddy makes these type of statements where she is trying to emphasizing that there are non-whites in her family. She is trying to implying that she has personal

decided to accept these **nephews and nieces who are half Black** into her family despite their difference in their skin complexion.

The Kumbaya / Color Blind Routine

So Stella Reddy believes that if she plays **The Kumbaya / Color Blind Routine** that she does not notice her **nephews and nieces** for what they are, non-whites. That everyone will buy into her I am not a racist, because **I don't speak that way** propaganda.

It is a good thing that Stella Reddy was so willing to be color blind to her own **nephews and nieces**.

– And, my nephew is as black as you can get! –

So Stella Reddy again decides it is now time to point out that her **nephew is a black as you can get**.

Again does Stella Reddy think that stating that her nephew is as black as you can get, is somehow away to explains away all of her racist and anti-black behavior she has committed?

So let us put Stella Reddy's statement into a visual perspective.

The above individual would be considered to have a very dark complexion. Basically speaking like Stella Reddy, he is as **black as you can get**.

Now according to Stella Reddy her **nephew is as black as you can get**.

This Stella Reddy statement would be true, if it was not a deliberate lie!

The Liar / Catch Me If You Can Routine

You see there are a few problems with Stella Reddy's use of these racist slur about her **nephew** who **is as black as you can get**.

Problem number one is that the below pictures are samples / clips of her actually bi-racial **nephews and nieces**.

*Does Stella Reddy really see her own **nephews and nieces** as being as darker than the male individual in the above picture?*

It is a pretty easy comparison to determine that they are clearly not even close in complexion.

The Liar / Catch Me If You Can Routine

*Problem number two is by looking at picture of the female from the interracial married couple / tenants. It is again pretty clear that Stella Reddy's bi-racial **nephews and nieces** have a significantly lighter complexion than she does.*

*Again does Stella Reddy really see her own **nephews and nieces** as being BLACKER than the female from the interracial married couple / tenants?*

*Stella Reddy clearly stated her **nephew is as black as you can get**. There is absolutely no debate on this being said.*

The Objectifying / Prop Routine

– He's even darker than she is! –

When Stella Reddy set out to try and do was embarrass the female from the interracial married couple / tenants by pointing at her in a public forum.

Stella Reddy pointed and objectified and used the female from the interracial married couple / tenants as a prop in a public form to dispute that she is not racist and THAT SHE DOES NOT USE ANTI-BLACK ACTIONS.

As the writer, I'm shaking my head right now to that above paragraph.

Stella Reddy could have pointed, objectified and singled out any other individual in the gallery that were for their own personal business, who were also Black or Brown individuals.

But Stella Reddy did not have the nerve or the balls to disrespect a total stranger sitting in the gallery.

Stella Reddy felt far more confident and comfortable use Colorism and disrespecting and embarrassing the female from the interracial married couple / tenants in front of her husband, children, the gallery, her own husband [REDACTED], her bosses [REDACTED] and his son Anthony Lisico and the racist Caucasian SJTO member [REDACTED].

The Objectifying / Prop Routine

Now it is one thing that Stella Reddy lied under oath, in a legal proceedings about her nephews light skin complexion to try and justify why she is not a racist.

But what makes it worse is that Stella Reddy thought that by making him Blacker than he really was. Helped her even more in proving she was not a racist.

*Did Stella Reddy decided to make him Blacker as to show that her love for her **nephews** has no boundaries no matter what his complexion?*

In some sick and twisted logic it appears that Stella Reddy thinks that by making her nephew Blacker, it proves she is not a racist.

There is no arguments that society discriminates based on an individuals skin color. Society often prefers light skinned individuals over verse darker skinned complexions.

A 2011 study that found people of mixed race are placed below Whites socially, but ahead of Blacks.

So what appears to be happening here is that Stella Reddy lies and wants to make her **nephew as black as you can get**. Using Colorism try to subtly imply that she is better than the rest of society and does not judge him on his (imaginary) **Black as you can get** complexion. That she does not favor one **nephew or niece** over the other. Despite mentioning and using only one of the four of them.

STUDY: Light-Skin Blacks Preferred Over Dark-Skin Ones

It appears that Stella Reddy only wanted to Black'n one of the four children to prove her point, as four would have be to unbelievable?

We really have to wonder if Stella Reddy's **nephews and nieces** would still be as beautiful to her if they were all really as BLACK as she deliberate tried to portray her own nephew as being?

The Objectifying / Prop Routine

And once again Stella Reddy performed the **The Objectifying / Prop Routine** of her Black nephew, but this time with a another twist.

This time she objectified **her black as you can get** nephew against the female from the interracial married couple / tenants.

Stella Reddy at this point, pointed and directed her finger straight at the female from the interracial married couple / tenants using her as a visual prop and her nephew as a comparison verbal **Black as you can get** prop in what we now know was a deliberate lie.

There was absolutely no reason to get the female from the interracial married couple / tenants involved in her deliberate lie. And there was not reason to compare their two individuals complexions against each other.

The fact that Stella Reddy used these racist slurs and anti-black behavior in a public forum, with a gallery full of people of every nationality, race and sex is astounding.

Stella Reddy made these remarks without fear of repercussions or consequences from the racist Caucasian SJTO member [REDACTED].

Stella Reddy must have really been comfortable and felt at home at the SJTO Landlord and Tenant Board hearing in front of the racist Caucasian SJTO member [REDACTED] to do this!

Whatever Stella Reddy's twisted racist and anti-black logic is. Stella Reddy decided to;

- *Black'n one her nephew,*
- *a bi-racial child,*
- *who is really of light complexion,*
- *used him as a verbal prop,*
- *compared her nephews complexion to that of the female from the interracial married couple / tenants*

to somehow justify why she is not a racist and a bigot!

*An again, let us recap how Stella Reddy vehemently claims time and time again that I **don't speak that way.***

– I have no issue with any kind of race –

It is hard to believe that Stella Reddy is try to portray herself as the Good Samaritan who is Color Blind to everything and everyone around her. But the facts are that Stella Reddy;

- *Deliberately lies about a Black female.*
- *Uses racist language and stereotypes to describe a Black female.*
- *Uses prejudice slurs about non-whites and other Canadians from Newfoundland.*

Stella Reddy and the property owners [REDACTED] and his son [REDACTED] were not their first, nor be their last rodeo!

But yet again the racist Stella Reddy tried to muddy the waters with her deliberate lies in hopes that once again it would become a he said / she said situation as to what really happen in regards to the Tenant Service Request Form.

*The racist Caucasian Stella Reddy was also counting on the **I Am The Caucasian / Canadian In The Room Routine**. Hoping that because she was Caucasian and born in Canada. That this would give her more credibility when being judge as to if she really received the Tenant Service Request Form from the interracial married couple / tenants.*

*Stella Reddy deliberately lied and used **The Objectifying / Prop Routine** tried to portray the interracial married couple / tenants as nothing more than liars and disgruntled tenants with her own deliberate lies **AGAINST THEM!***

Refused To Give Interracial Couples / Tenants Parking Spots Pt – 3

You see Stella Reddy in the past had absolute no problem with giving the interracial married couple / tenants a parking space for their CAR RENTALS. But the moment that they were getting ahead and bought a brand new vehicle.

Suddenly Stella Reddy became infuriated with them and refused to give them a parking space that they were entitled too, for free on their application.

You have to understand that at this time Stella Reddy and her husband [REDACTED] [REDACTED] had two vehicles parked at the building. One had been off the road since April 2015 that they brought with them and parked in the indoor garage. And they purchased a 2nd vehicle when they first moved in, but could not afford to drive it and eventually had to get rid of it.

Racist hate to see any non-white getting ahead while they are still struggling to just get by. Stella Reddy is and was so jealous and pissed off to see that the interracial married couple / tenants were able to buy a vehicle, especially a brand new vehicle.

And here is Stella Reddy and her husband [REDACTED] struggling to survive of two incomes. Having to get ride of there 2nd vehicle they bought when they fist moved in.

Even with two incomes and them getting rid of their 2nd vehicle. Stella Reddy and [REDACTED] still could not afford to get their 1st vehicle that has been off the road since April 2015 working and insured and back on the road.

The same vehicle that they brought and parking in the indoor garage when they moved in back in July 2016.

Stella Reddy and her husband [REDACTED] were extremely jealous of the fact that the male of the interracial married couple / tenants was a stay at home / work from home dad. And that the female of the interracial married couple / tenants was a successful self-employed event coordinator.

And this is why the racist Stella Reddy really refused to give the interracial married couple / tenants a parking space.

Stella Reddy has mentioned this fact numerous times in legal documents about how the husband did not work and how his wife had to go to work everyday while the vehicle was parked at the building.

“Even when they got their car, I still saw some mornings Mrs. ** standing at the bus stop across the street, I assume to go to work, with a car sitting there in Visitors Parking. Mrs. ***** was the one working so I assume the car was paid from her income and yet she still took the bus so Mr. ***** could have the car sitting here in Visitors all day that he had for his own personal use. He didn’t have a job though, at least not one that brought in any income.”***

Stella Reddy goes on that it is some far fetched idea to think that people take public transit in the city of Toronto to go work?

Stella Reddy really wants people to believe that EVERYONE who has a vehicles in Toronto use them to go to work! That only people who do not own vehicles use public transit.

These types of statements are a regular thing from the racist Stella Reddy.

Stella Reddy hated and despised the idea of what she perceived as a single income home, with a working BLACK FEMALE who was able to make enough money to pay all of the families bills (rent, phones, hydro, internet, cable, transportation, groceries ect.) while she and her husband [REDACTED] had to sell off their 2nd vehicle and could not afford to fix their 1st vehicle on a 2 income household.

And this is what fuels racism in Canada. When Caucasians feel that it is their rights and entitlement as Caucasian and Canadian born. To have what they determine as success and to be financially independent and secure.

*This is called the racist **I Am The Caucasian / In The Room Routine.***

- *Stella Reddy to this day can not stand the idea that a BLACK female makes more money than her and her husband make combined.*
- *Stella Reddy to this day can not stand the idea that a BLACK female was able to buy a BRAND NEW vehicle and they could not afford any to fix or keep any of their vehicles.*
- *Stella Reddy to this day can not stand the idea that a BLACK female is more financially independent and self-supporting than she is. As Stella Reddy now refuses to work and now wants to depend and lives off only husbands income.*

- Stella Reddy to this day can not stand the idea that a BLACK woman was able to move out and find a another place after getting away from a self admitted stalker, Stella Reddy.

Canadian judge acknowledges anti-black racism in court – June 28, 2016

"Citing statistics highlighting the dramatic increase in black prisoners in Canada (upwards of 80% over the past decade), and acknowledging that social factors, particularly anti-black racism, were root causes, he wrote "while this court is not in a position to remedy the societal issues, it can and should take the societal context into account in fashioning an appropriate sentence for an individual offender.

Indeed, a fundamental principle in Canadian law is that "a sentence must be proportional to the gravity of the offence and the degree of responsibility of the offender." To put things simply, Justice Morgan acknowledged both the existence of anti-black racism in Canada and its influence on one's participation crime and criminal justice. Having turned his life around, Morgan did not want Reid become another statistic. Given what we now know about the serious negative consequences of incarceration, our society would benefit if more members of the Canadian judiciary followed suit."

Court of Appeal for Ontario, R. v. Wilson, 1996 CanLII 376 (ON CA)

"It is unrealistic and illogical to assume that anti-black attitudes stop at the borders of Metropolitan Toronto. The trial judge erred in refusing to allow the accused to challenge prospective jurors for cause on the basis of racial bias. The trial judge's own personal experience could not be objectively verified and

therefore represented a very difficult area for the exercise of judicial discretion. Any distinction based on a geographical boundary between Metropolitan Toronto and communities elsewhere in Ontario is arbitrary and should not form the basis for a judicial exercise of discretion to refuse the challenge. Judicial notice is taken that there are a higher number of black persons residing inside Metropolitan Toronto than outside that metropolis. People who have fewer interactions with black persons are probably more likely to have negative views of black persons and thus the judicial system must be concerned about the potential of racial prejudice outside Metropolitan Toronto."

1. c. Mankwe, 1997 CanLII 17471 (QC CS)

"Doherty J.A. has therefore accepted the fact that the evil of racism in contemporary Canadian society is a reality and that blacks are among the principal victims of "that evil". While some of his concerns focus on Metropolitan Toronto, I can find nothing in his comments which would suggest that the evil of racism, as it affects blacks, is significantly less of a concern outside the boundaries of Metropolitan Toronto. There is no evidence before this court to explain the growth of anti-black racism in Canada, or to single out Metropolitan Toronto in particular. I take judicial notice of the fact that the principal concentration of Ontario's black citizens is in Metropolitan Toronto, but that in my opinion does not lead to any rational conclusion that anti-black attitudes would therefore be less evident elsewhere in Ontario. The media philosopher Marshall McLuhan used the term "global village" to describe the impact of the media, and of television in particular, on the lives of the majority of our citizens. The influence of negative stereotyping on all of the citizens of Ontario cannot therefore be underestimated."

We will never know because not even Stella Reddy can explain away the irrelevant to it when using it as a defense or a justification for Government Agencies to get involved.

R v. Kandhai, 2020 ONSC 3580 (CanLII) June 9, 2020

"In light of the prevalence of anti-black prejudice, it ought to come as no surprise that it is also an established fact that African Canadians are overrepresented in the criminal justice system and in the jails."

"I did reach out to Ontario Health and Safety recently and spent over an hour on the phone with them talking about this situation... and filed a complaint, on the interracial married couple / tenants! This is so an investigation can be done about

the Adult Bullying and obvious Smear Campaign online instigated by them against me and other family members, even the owners! Even other tenants living here could be affected by the target the interracial married couple / tenants placed on me and the property. I had a nice chat, was told what could be done, and it will be done. Even my sister can file a complaint, as she is also named on these sites."

But enough about that. That is for a different site.

Now back to White Pride Stella Reddy.

Stella Reddy quickly is running out of people and Government Agencies to cry too. She has now desperately resorted to going to the Ministry of Labour – Ontario Health and Safety complain about the indisputable documents and facts on these sites.

Let us note that the Ministry of Labour – Ontario Health and Safety is there to protect all workers and their rights to return home each day safe and sound.

Let us clarify that the Ministry of Labour – Ontario Health and Safety's mandate is to preventing work-related illness and injury at any workplace.

The Ministry of Labour – Ontario Health and Safety enforces the Occupational Health and Safety Act.

*Not sure how Stella Reddy figures this applies to anything that relates to the interracial married couple / tenants? Maybe she got this "**wonderful**" advice from her White Pride buddy/friend Cherie White?*

It is at this point it is not worth any else time to address any more of Stella Reddy White Pride foolish behavior or her White Pride friend Cherie White and her White Pride husband John White.

It has been pretty and obviously established at this point that Stella Reddy is a desperate racist who is running out of options in her attempts to stop her past from biting her in the ass. Stella Reddy is a performer who puts on whatever face/mask is needed for the time. It is that plan, and it is that simple. This website drives her crazy because it exposes just that, her act.

With that said, our family has moved on with our lives. Forgetting about Stella Reddy and her ignorant family. Our lives are solely about our children becoming doctors and being more productive in society, more than Stella Reddy and her family have nor ever will be able to.
