Same with these parking pages... Gaslighting you into believing that I was stupid to do for others I wouldn't do for these tenants, knowing they would find out and use their big mouths to complain over it... Just what they did on these pages.

Toxic Adult Bullies tries to get you to believe that they were entitled to a free parking space, yet he has no proof of it. Gaslighting, trying to get you to believe their claims of free parking though they have no documentation proving it. Such jealousy was expressed there as well, jealous that others had parking, some even with 2 spots, and here they couldn't even get one. They are so jealous they have to write about my 2 vehicles too! If they weren't jealous over that, why mention it? My vehicles were none of his business and neither were the other tenants.

Before we start. Let it be noted that the interracial married couple / tenants we entitled to one parking space with the rental of the unit and it was free. Stella Reddy ALWAYS forgets to tell people this important fact!

This page, on Karma, is interesting in its Gaslighting. There is also so much triangulation here as well with the owners! I could tell Toxic Adult Bullies was pissed over this page I shared on July 26, 2020, where I talk of speaking to Ontario Health and Safety.

I write about Ontario Health and Safety and Toxic Adult Bullies has to speculate on what he thinks it means and degrade me in the process over mental health issues. Toxic Adult Bullies isn't a doctor yet is proceeding to diagnose me, as he always does when he is mad.

Gaslighting by trying to convince you that we were evicted, or fired, and as a result, can't afford to pay rent there anymore and have to leave. Of course, he refuses to write that we decided to quit and move out on our own. That option isn't mentioned as it shows we had a choice, not that we were being forced like he wanted to believe.

Gaslighting you to believe that my mental health issues are fake and imaginary as of course Toxic Adult Bullies refuse to believe his actions have any effect on it.

I called Health & Safety after I found out the property owners were not going to go to Civil Court over the websites online by Toxic Adult Bullies and wanted to know what our options were and they gave me quite a few. The main one was to leave and get away from the threat these domains, and their contents represented to my health and my personal safety. My Husband gave a Month's written Notice on August 14, 2020, but they knew since June we were leaving in September 2020. it took about 3 months to plan this move and to build up the funds to do it with! Yes, we had plans to retire at Kennedy Rd, but plans changed.

We left Ontario as I could no longer deal with the severe fear generated within me with those domains online as they are. I truly believe that Toxic Adult Bullies was trying to instigate others against me and I still believe it. His words give him away...

Stella Reddy posted on her blog yesterday July 26, 2020

So why the sudden change of heart by Stella Reddy?

Because either the racist Stella Reddy and her enabler husband [REDACTED] have been evicted from their unit at 859 Kennedy Road by L and his son A.

Or L and his son A have finally decided that the websites are too much for them and have finally fired R after 4 years of a media-oker cleaning around the building.

No matter what the reason, it does mean that Stella Reddy and her enabling husband can not afford to pay the rent to live there anymore and have to “cut all ties to this building and to Ontario. I am going home” to Newfoundland

Either way it appears that the racist Stella Reddy and her enabling husband are on the move due to something L and his son A have done. And they are pissed off about it. Threatening to now get the Ontario Health And Safety after them!

Stella Reddy’s big plan that she continuously bragged and boosted about to retire and live a happy conformable life at 859 Kennedy Road are NOW OVER!

You see Stella Reddy and her enabling husband can not afford to live in Toronto, as NEITHER ONE OF THEM ARE PROBABLY WORKING now, and Stella Reddy, who is leeching off the Government of Canada for her Canada Pension Plan Disability Benefits only gets as she states “\$694.16 per month”

It is amazing is how Stella Reddy conveniently was able to suddenly work in June 2016, despite her February 2015 Cervical Spinal Stenosis diagnosis of which got her approved for for her Canada Pension Plan in March 2016.

“at the time, I was not able to work due to a newly diagnoses of Cervical Spinal Stenosis, which was causing severe pain in my left side from my neck that I developed in Feb 2015, and this is why I had to stop working. As we had worked in this property for 3 years as building staff, the management approved us for an apartment. It was also during this time that I closed my personal bank account and is currently using my husbands. Due to the stenosis I applied and was approved for CPP Disability in March 2016, which I am still receiving.”

Stella Reddy also likes to claim that she has imaginary Post-traumatic stress disorder (PTSD) from a house fire in Newfoundland back 29 years ago in 1991.

Stella Reddy’s behavior is an insult to all individuals who really have PTSD.

Stella Reddy uses her conveniently fabricate PTSD as a crutch and a way to to leech off the Canadian government. Just like she did to her husband and enabler [REDACTED] when she decided she wanted to retire from Property Management and live off his small cleaning income.

More Gaslighting, I recall standing there in July 2016 at the Entry Panel removing all the keyless entry codes that were in the system and I have still a copy of the Notice that went out letting tenants know it was done. Yet, here is Toxic Adult Bullies trying to Gaslight everyone into believing that I didn't do that, that I was imagining I did that, as the code, he was given still worked. Toxic Adult Bullies wants you to believe that all the times the keyless codes were either removed on purpose or by power outages, the code he had since moving in magically still worked for him and he had no problem using it.

Toxic Adult Bullies want you to believe that Stella Reddy is a liar and that it was not possible for someone to see him use this code to gain entry. Of course, there is no way this could have happened the way Stella Reddy said it did, she is a liar and stupid and doesn't know anything.
